

ORDER OF AN EXECUTIVE OFFICER

To: 2145151 Ontario Inc.

"the Owner"

RE: Those housing premises located in Red Deer, Alberta and municipally described as:

4614 41 Avenue, Red Deer, AB - Main Floor.

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The premises is in structural disrepair as evidenced by high moisture meter readings on the ceiling in the northwest bedroom and the south wall in the bathroom.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

a. There are high moisture meter readings on the ceiling in the northwest bedroom and evidence of water damage to the south wall of the bathroom. This condition is contrary to Section 5 of the Minimum Housing and Health Standards, which states: "All walls, windows, floors, and floor coverings shall be maintained in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean."; (a) Rooms containing a flush toilet and/or a bathtub or shower shall have walls and floors that are smooth, non-absorbent to moisture and easy to clean. All walls shall form a watertight joint with each other, the floor, the ceiling and where applicable with the bathtub or shower."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Remove/replace water damaged materials in the northwest bedroom and the bathroom.
 - b. Inspect areas behind the water damaged materials for mould growth. If mould growth is present it must be properly remediated.
- 2. The work referred to in paragraph 1 shall be completed by August 21, 2019.
