

**ORDER OF AN EXECUTIVE OFFICER
NOTICE OF CLOSURE**

WHEREAS I, Kevin McLeod, an Executive Officer of Alberta Health Services, have inspected the above premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder the prevention or suppression of disease, namely:

- a. The sale and unrefrigerated display of a perishable food product to wit: Kingsey Brand, Cheese Curds, manufactured on January 18, 2011 by Saputo, Incorporated, Montreal, Quebec.
- b. The sale and unrefrigerated display of a perishable food product to wit: Tortillon, Princesse cheese curds, manufactured by Saputo, Incorporated, Montreal, Quebec

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Regulations there under exist in and about the above noted premises, namely:

Food Regulation, Section 25(1) A.R. 31/2006

All high-risk food must be stored, displayed and transported at a temperature of

- a) not more than 4 degrees C or such higher temperature, or
- b) not less than 60 degrees C or such lower temperature as an executive officer stipulates under subsection (4).

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be Closed.

NOW THEREFORE, I hereby ORDER and DIRECT:

1. That you immediately close the above noted business until the above executive officer is satisfied that there is an adequate method of refrigeration provided for the perishable products as identified above.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.

You have the right to appeal

A person who a) is directly affected by a decision of a Regional Health Authority, and
b) feels himself aggrieved by the decision

may appeal the decision within ten (10) days after receiving the order to the Public Health Appeal Board located at 24th Floor, Telus Plaza, 10025 - Jasper Avenue, Edmonton, Alberta, T5J 1S6. Telephone (780) 427-2813.

The terms of this Order remain in effect notwithstanding the filing or proposed filing of any such appeal. If you appeal, you may also make an application to the Board for a stay of this Order pending the appeal.

You are advised that all orders remain in effect pending such an appeal
