

ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE

To: Can Fung Investments Ltd. "the Owner"

RE: The food establishment located in Calgary, Alberta and municipally described as: Can Fung Food Service – Warehouse Expansion Area 5631 Burbank Road SE

WHEREAS I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The beef processing area, including cutting tables and two slicers, was expanded to the warehouse without approval. The warehouse area does not have a handwashing sink, dishwashing sink or floor drain.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

a. The beef processing area, including cutting tables and two slicers, was expanded to the warehouse without approval. The warehouse area does not have a handwashing sink, dishwashing sink or floor drain. This is in contravention of section 16 of the Food Regulation AR 31/2006, which states that: A person must not construct or make alterations to a commercial food establishment unless plans and specifications for the construction or alterations, as the case may be, have been approved by the executive officer.

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed**.

NOW THEREFORE, I hereby ORDER and DIRECT:

- 1. That the Owner immediately close the above noted premises.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:

- a. Immediately cease all food handling in the warehouse.
- b. Submit a floor plan to an Alberta Health Services Executive Officer to move the slicers and cutting tables into the permitted cutting room; or stop using the additional slicers and cutting tables and immediately remove or store the equipment.
- c. Submit a floor plan for the new processing room for review by an Alberta Health Services Executive Officer. The floor plan must be to scale and clearly identify and describe all surfaces, plumbing, plumbing fixtures and equipment.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
