

ORDER OF AN EXECUTIVE OFFICER

RE: The food establishment located in Calgary, Alberta and municipally described as:

Fritou Chicken 130

33 - 4307 130 Avenue SE

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. There was no handwashing sink in the kitchen.
- b. There were no soap or paper towel dispensers in the kitchen.
- c. The soap and paper towel dispensers at the front area handwashing sink outside of the kitchen were both empty.
- d. Food handlers were unable to properly wash their hands.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. There was no handwashing sink in the kitchen. This is in contravention of the Food Regulation AR 231/2006 section 17(1)(e), which states that: An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment has handwashing stations that are adequate in number and situated so as to ensure convenient access by all food handlers.
- b. There were no soap or paper towel dispensers in the kitchen. This is in contravention of the Food Regulation AR 231/2003 section 30(4), which states that: The handwashing stations referred to in Section 17(1)(e) must be maintained and kept supplied.
- c. The soap and paper towel dispensers at the front area handwashing sink outside of the kitchen were both empty. This also contravenes section 30(4) of the Food Regulation AR 231/2003 as referenced above.
- d. Food handlers were unable to properly wash their hands. This is in contravention of the Food Regulation AR 231/2006 section 30(1)(d) which states that: A food handler must wash hands as often as necessary to prevent the contamination of food or food areas.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Install a designated handwashing sink in the kitchen. Ensure the sink complies with local building code.
 - b. Equip the newly installed sink with both soap and paper towels in suitable dispensers.
 - c. Equip the front area handwashing sink with soap and paper towel in suitable dispensers.
 - d. Ensure food handlers are trained on proper handwashing technique and that they have quick and easy access to doing so.
- 2. The work referred to in paragraph 1 (a&b) shall be completed by June 28th, 2024.
- 3. The work referred to in paragraph 1 (c&d) shall be completed by June 18, 2024.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
