

## **ORDER OF AN EXECUTIVE OFFICER NOTICE OF CLOSURE**

**RE:** The food establishment located in Calgary, Alberta and municipally described as:  
Osmow's  
310 - 4501 17 Avenue SE

**WHEREAS** I, an **Executive Officer** of **Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Sewage was backing up throughout the food establishment. Sewage water was observed in the women's washroom, the hallway, the kitchen, and there was a strong sewage odour in the walk-in refrigerator.
- b. The cold-water handle for the front service area handwashing sink was not operational; there was no cold running water at the handwashing sink.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

- a. Sewage was backing up throughout the food establishment. Sewage water was observed in the women's washroom, the hallway, the kitchen, and there was a strong sewage odour in the walk-in refrigerator. This is in contravention of section 17(1)(f) (ii) of the Food Regulation AR 31/2006 which states that: An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment is connected to a lawful and properly operating sewage disposal system.
- b. The cold-water handle for the front service area handwashing sink was not operational; there was no cold running water at the handwashing sink. This is in contravention of section 17(1)(e-f)(i) of the Food Regulation AR 31/2006 which states that: An operator must ensure that, before operation of the commercial food establishment commences, the commercial food establishment has handwashing stations that are adequate in number and situated so as to ensure convenient access by all food handlers, and is supplied with hot

and cold running water that is safe for human consumption and available in quantities sufficient to meet the needs of the commercial food establishment.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately close the above noted premises.
2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Retain the services of a professional technician(s) to assess the plumbing lines and repair all deficiencies to stop sewage back up. Properly remediate all building materials damaged by the sewage backup.
  - b. Ensure all surfaces, including, but not limited to: floors, walls, food preparation tables and cutting boards; all high touch surfaces (door handles, light switches, sink taps etc); all equipment surfaces (coolers, freezers, fryers etc); are thoroughly cleaned and sanitized with an appropriate sanitizer (i.e. bleach solution).
  - c. Repair the cold-water handle for the front handwashing sink so cold running water is available at all times.
3. That until such time as the work referred to above is completed to the satisfaction of an Executive Office of Alberta Health Services; the above noted premises shall remain closed.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
