

ORDER OF AN EXECUTIVE OFFICER Boil Water Order

To: Morning Glory Water Association

"the Owner"

RE: The Drinking Water Supply located in Starland County, Alberta and municipally described

as: Starland Regional Waterworks System - Morning Glory Water Association

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted drinking water supply pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted drinking water supply which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The water supply serving the Morning Glory Water Association may be unsafe for human consumption due to bacteriological contamination including the presence of E. coli.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 exist in and about the above noted Drinking Water Supply, namely:

a. The water supply serving the Morning Glory Water Association may be unsafe for human consumption due to bacteriological contamination including the presence of E. coli in the water distribution system which is in contravention of the Nuisance and General Sanitation Regulation Section 11, which states "Where a person provided a source of water that the person intends to be used or realizes or ought to realize will be used by the public for human consumption, the person shall ensure that the water is potable".

AND WHEREAS by virtue of the foregoing, the above noted Drinking Water Supply is hereby declared **unfit for human consumption**;

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the Owner immediately issues a Boil Water Advisory to all users of the above noted Drinking Water Supply.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted drinking water supply, namely:
 - a. Advise all affected residents that water used for drinking, making infant formula and juices, cooking, making ice, washing fruits, vegetables or brushing teeth, must be boiled for at least 1 minute prior to use.
 - b. Submit two sets of bacteriological water samples taken from three locations and at least 24 hours apart that show no presence of Total Coliforms or E. coli.

3. That, until such time as the work referred to in paragraph 2 is completed to the satisfaction of the undersigned, or an executive officer of Alberta Health Services, that this order shall remain in effect.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
