

ORDER OF AN EXECUTIVE OFFICER

- **RE:** Those housing premises located in Edmonton, Alberta and municipally described as:

10603 107 Avenue NW Edmonton, AB T5H 0W4

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. Occupants of two separate units within the building reported to Alberta Health Services Environmental Public Health that the power supply to their unit had been disconnected by the property owner. This power disconnection affected adequate heat supply.
- b. The same occupants reported that unit door locks had been removed by the property owner.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. Occupants of two separate units within the building reported to Alberta Health Services Environmental Public Health that the power supply to their unit had been disconnected by the property owner. This power disconnection affected adequate heat supply. This is in contravention of Sections 8 and 11 of the Minimum Housing and Health Standards, which state that "(a) All heating facilities within a housing premises are to be properly installed and maintained in good working condition, and be capable of safely and adequately heating all habitable rooms, bathrooms, and toilet rooms within the building to a temperature of ; (i) at least 22°C(71°F), or (i) maintained at a temperature of at least 22°C(71°F) when the control of the supplied heat in a dwelling is the responsibility of a person other than the occupant. ", and furthermore that, "Every housing premises shall be supplied with electrical service. Outlets, switches and fixtures shall be properly installed and shall be maintained in a good and safe working condition."
- b. The same occupants reported that unit door locks had been removed by the property owner. This is in contravention of Section 3(a) of the Minimum Housing and Health Standards, which states that "Exterior windows and doors shall be capable of being secured."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following:

- a. Restore and maintain power to all occupied units within the building. Ensure power is maintained at all times during which the unit is occupied.
- b. Replace the missing or damaged locks to all units in the building. Ensure the locks are maintained in proper, operating condition at all times.
- 2. The requirements referred to in paragraph 1 shall be maintained while units are occupied, and the landlord is responsible for providing the items noted in paragraph 1.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
