

ORDER OF AN EXECUTIVE OFFICER CLOSED FOR TENANT ACCOMMODATION PURPOSES ORDER TO VACATE

To: Vuong Van Tai Holding INC. Van Vuong "the Owner" "the Owner"

And To: All Occupant(s) of the following Housing premises:

RE: Those housing premises located in Edmonton, Alberta and municipally described as:

408 - 10603 107 Avenue NW Edmonton, AB T5H 0W5

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The following building materials were damaged at the time of inspection: the casing around the entrance door was in disrepair; the left bedroom door and door casing were damaged; the right bedroom door casing was detached from the wall in places; one of the kitchen cabinet doors was partially off its hinges.
- b. The carpets throughout the suite were heavily stained, torn or otherwise damaged throughout the living room and the two bedrooms.
- c. The wall finishes were in disrepair in places including: the wall opening in the left bedroom was in disrepair; the right bedroom was missing baseboards; the right bedroom windowsill was in disrepair.
- d. A bedroom switch plate cover was broken in the first room.
- e. There was a complaint of a cockroach infestation, which is present in other areas of the building.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The following building materials were damaged at the time of inspection: the casing around the entrance door was in disrepair; the left bedroom door and door casing were damaged; the right bedroom door casing was detached from the wall in places; one of the kitchen cabinet doors was partially off its hinges. This is in contravention of Section 1(c) of the Minimum Housing and Health Standards, which states that "Building materials that have been damaged or show evidence of rot or other deterioration shall be repaired or replaced."
- b. The carpets throughout the suite were heavily stained, torn or otherwise damaged throughout the living room and the two bedrooms. This is in contravention of Section 5 of

the Minimum Housing and Health Standards, which states that "All walls, windows, ceilings, floors, and floor coverings shall be maintained in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean. (a) Rooms containing a flush toilet and/or a bathtub or shower shall have walls and floors that are smooth, non-absorbent to moisture and easy to clean. All walls shall form a watertight joint with each other, the floor, the ceiling and where applicable with the bathtub or shower. (b) Rooms and sections of rooms that are used for food preparation and cooking shall have walls and floors constructed of materials which do not provide harbourage to dirt, grease, vermin and bacteria and that are easily kept clean."

- c. The wall finishes were in disrepair in places including: the wall opening in the left bedroom was in disrepair; the right bedroom was missing baseboards; the right bedroom windowsill was in disrepair. This is in contravention of Section 5 of the Minimum Housing and Health Standards, which states that "All walls, windows, ceilings, floors, and floor coverings shall be maintained in good repair, free of cracks, holes, loose or lifting coverings and in a condition that renders it easy to clean. (a) Rooms containing a flush toilet and/or a bathtub or shower shall have walls and floors that are smooth, non-absorbent to moisture and easy to clean. All walls shall form a watertight joint with each other, the floor, the ceiling and where applicable with the bathtub or shower. (b) Rooms and sections of rooms that are used for food preparation and cooking shall have walls and floors constructed of materials which do not provide harbourage to dirt, grease, vermin and bacteria and that are easily kept clean."
- d. A bedroom switch plate cover was broken in the first room. This is in contravention of Section 11 of the Minimum Housing and Health Standards, which states that "Every housing premises shall be supplied with electrical service. Outlets, switches and fixtures shall be properly installed and shall be maintained in a good and safe working condition."
- e. There was a complaint of a cockroach infestation, which is present in other areas of the building. This is a contravention of Section 16(a) of the Minimum Housing and Health Standards which states that "The owner shall ensure that the housing premises are free of insect and rodent infestations; and (i) all situations requiring the application of pesticides must be applied in accordance with the Environmental Protection and Enhancement Act and regulation; and (ii) whenever a pesticide is applied in a dwelling, the occupant shall be notified in accordance with the latest edition of the Environmental Code of Practice for Pesticides published by Alberta Environmental Protection. (iii) it is the occupants responsibility to allow access in accordance to the Residential Tenancy Act to do whatever is necessary to ensure the dwelling unit is ready for pesticide application."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Closed for Tenant Accommodation Purposes**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That the occupants vacate the above noted premises immediately, as it is vacant.
- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:

- a. Repair/replace the damaged building materials listed above, including: the casing around the entrance door, the left bedroom door and door casing, the right bedroom door casing, and the kitchen cabinet door that was in disrepair.
- b. Replace the carpet throughout the suite as it was heavily stained, torn or otherwise damaged.
- c. Repair the walls within the unit to ensure they are smooth, impervious to moisture, and easy to clean.
- d. Replace the broken switch cover plate in the bedroom.
- e. Hire a licensed pest control operator to assess the presence of cockroaches in the suite and treat accordingly. *Provide copies of any pest records to this office*.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain closed for tenant accommodation purposes.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
