

ORDER OF AN EXECUTIVE OFFICER UNFIT FOR HUMAN HABITATION ORDER TO VACATE

To: Theodore Kulchisky

"the Owner"

And To: All Occupant(s) of the following Housing premises:

RE: Those housing premises located in Edmonton, Alberta and municipally described as:

Unit 45, 4515 – 76 Avenue NW

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

Based on information received from the Strathcona RCMP Drug Unit,

- a. the premises was suspected of being used to process and/or distribute fentanyl. It is likely that some of these substances were tracked and/or involuntarily dispersed into other parts of the premises and traces of the powder or residual remains.
- b. The mobile home was insanitary and heavily cluttered with garbage/random items piled up throughout the premises.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Nuisance and General Sanitation Regulation, Alberta Regulation 243/2003 exist in and about the above noted premises, namely:

a. Items [a] and [b] are in contravention of section 5(2) of the Housing Regulation which states that "No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the public health, including any condition that may hinder in any way the prevention or suppression of disease" and/or section 2(1) of the Nuisance and General Sanitation Regulation which states that "No person shall create, commit, or maintain a nuisance."

AND WHEREAS, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the occupants vacate the above noted premises immediately.

- 2. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
 - a. Hire the services of a professional remediation company that specializes in hazardous materials remediation to clean the premises of suspected fentanyl and residual. Cleaning of the premises must be completed in such a manner that protects the public and future occupants from fentanyl contamination during and after the cleanup.
 - Submit a remediation plan to an Executive Officer of Alberta Health Services for approval and acceptance before undertaking any clean-up at the premises.
 This remediation plan is to include but is not limited to:
 - A full assessment of the entire premises to determine the extent of contamination.
 - The scope of work necessary to remediate all parts of the premises.
 - Decluttering process.
 - Determination of what contents need cleaning and what is to be disposed of.
 - Restrictions on what contents can be removed from the premises, and/or determination of what contents can be removed from the premises with proper cleaning and appropriate neutralization of contaminants
 - c. Provide documentation of all work completed to an Executive Officer of Alberta Health Services.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
