

## ORDER OF AN EXECUTIVE OFFICER UNFIT FOR HUMAN HABITATION ORDER TO VACATE

To: "the Owner(s)"

And To: Any and all Occupant(s) of the following Housing premises:

8325 - 82 Avenue NW, Edmonton

Subject: Those premises / housing premises, and all structures on this property, located in

Edmonton, Alberta, municipally described as:

8325 - 82 Avenue NW

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

Based on (i) onsite observations and (ii) information received from the Edmonton Police Service (EPS), the premises

- a. was extremely cluttered and difficult to access, particularly at all door entrances/exits (front door main, front door basement, rear door main leading to basement staircase and back room/kitchen) and rooms (basement front room, main kitchen), and throughout premises
- b. had no electrical power supply
- c. had no natural gas supply
- d. exterior stairs / staircases and guards and handrails were in disrepair

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and Nuisance and General Sanitation Regulation (Alberta Regulation 243/2003) and/or the Housing Regulation (Alberta Regulation 173/99), and/or the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

a. Violation items (a) – (d) are in contravention of sections 2(1) and 2(2) of the Nuisance and General Sanitation Regulation which states that no person shall create, commit or maintain a nuisance, and, without limiting the generality of subsection (1), a person who creates, commits or maintains (a) any premises in a condition that, and/or (h) any building that due to (i) its not being in a clean state, is or might become injurious or dangerous to the public health or that might hinder in any manner the prevention or suppression of disease; and/or section 5(2) of the Housing Regulation which states that "No person shall cause or permit any condition in housing premises that is or may become injurious or dangerous to the

public health, including any condition that may hinder in any way the prevention or suppression of disease"

**AND WHEREAS**, by virtue of the foregoing, the above noted premises are hereby declared to be **Unfit for Human Habitation**.

## NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

- 1. That (any) occupants vacate the above noted premises immediately.
- 2. That the Owner(s) undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Hire a remediation company that specializes in fire/water damage restoration, waste, and/or hazardous materials remediation to assess and remove waste and clutter from all areas of the premises and property
  - Submit any remediation assessments and plans for review by an Executive Officer of Alberta Health Services
  - c. Provide documentation of all work completed to an Executive Officer of Alberta Health Services.
- 3. That until such time as the work referred to above is completed to the satisfaction of an Executive Officer of Alberta Health Services; the above noted premises shall remain vacant and secure from unauthorized entry.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
