

## **ORDER OF AN EXECUTIVE OFFICER**

**To:** Avenue Living Communities Ltd.  
"the Owner"

**RE:** Those housing premises located in Brooks, Alberta and municipally described as:  
1023 3<sup>rd</sup> Avenue East - Unit 110

**WHEREAS** I, an **Executive Officer of Alberta Health Services**, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

**AND WHEREAS** such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

- a. The sink cabinet door arborite edge is missing, allowing water absorption and causing swelling of the fiberboard.

**AND WHEREAS** such inspection disclosed that the following breaches of the Public Health Act and the Housing Regulation, Alberta Regulation 173/99, and the Minimum Housing and Health Standards exist in and about the above noted premises, namely:

- a. The sink cabinet door arborite edge is missing, allowing water absorption and causing swelling of the fiberboard. This is a contravention of section IV(14)(a)(ii) of the Minimum Housing and Health Standards which states that: Every housing premises shall be provided with a food preparation area, which includes: cupboards or other facilities suitable for the storage of food.

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:
  - a. Seal and refinish or replace kitchen cabinet doors.
2. The work referred to in paragraph 1 shall be completed by November 21, 2022.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
