

ORDER OF AN EXECUTIVE OFFICER

RE: The food establishment located in Coutts, Alberta and municipally described as:

Hills of Home Café, 111 1 Avenue South

WHEREAS I, an Executive Officer of Alberta Health Services, have inspected the above noted premises pursuant to the provisions of the Public Health Act, RSA 2000, c. P-37, as amended;

AND WHEREAS such inspection disclosed that the following conditions exist in and about the above noted premises which are or may become injurious or dangerous to the public health or which might hinder in any manner the prevention or suppression of disease, namely:

a. The sandwich preparation cooler (unit on left) across from the cooking equipment does not appear to be in working order. The cooler was observed to have the following temperatures: 13.6°C during a monitoring inspection conducted on March 24, 2022; 13°C during a monitoring inspection on September 22, 2022; 14.7°C during a re-inspection on October 20, 2022; 14.3°C during a re-inspection on November 4, 2022. At the time of each of these observations, high risk food items were stored in the unit.

AND WHEREAS such inspection disclosed that the following breaches of the Public Health Act and the Food Regulation, Alberta Regulation 31/2006 and the Food Retail and Foodservices Code exist in and about the above noted premises, namely:

a. The sandwich preparation cooler (unit on left) across from the cooking equipment does not appear to be in working order. The cooler was observed to have the following temperatures: 13.6°C during a monitoring inspection conducted on March 24, 2022; 13°C during a monitoring inspection on September 23, 2022; 14.7°C during a re-inspection on October 20, 2022; 14.3°C during a re-inspection on November 4, 2022. At the time of each of these observations, high risk food items were stored in the unit. This is in contravention of Section 25(1)(a) of the Food Regulation (AR 31/2006), which states "All high-risk food must be stored, displayed and transported at a temperature of (a) not more than 4°C or such higher temperature," **AND** Section 28(3) of the Food Regulation (AR 31/2006), which states "All equipment and utensils in a commercial food establishment must be (a) kept in good working order and condition, and (b) maintained in a manner that ensures the safe and sanitary handling of food."

NOW THEREFORE, I hereby **ORDER** and **DIRECT**:

1. That the Owner immediately undertake and diligently pursue the completion of the following work in and about the above noted premises, namely:

- a. Ensure that the sandwich preparation cooler is repaired and serviced by a professional. and that it can maintain a consistent temperature of 4°C or less at all times.
- b. Ensure that the sandwich preparation cooler is not used to store high risk foods until the owner/ operator has provided written documentation of repairs made by a professional service company to the undersigned Executive Officer.
- 2. The work referred to in paragraph 1 shall be completed by November 15, 2022.

The above conditions were noted at the time of inspection and may not necessarily reflect all deficiencies. You are advised that further work may be required to ensure full compliance with the Public Health Act and regulations, or to prevent a public health nuisance.
