Alberta Health Services	Linda Iwasiw, Chief Zone Officer and Dr. Aaron Low, South Zone Medical Director shared the following update:
Zone Update	<ul> <li>On the progress of the South Zone Healthcare Planning. The draft plan will be shared with engaged stakeholders early January 2024 before approval and will be aligned with government direction. Updates can be found on Together4Health.ca</li> <li>On the AHS Enhanced Masking Directive, and which sites in Alberta have currently implemented the directive.</li> <li>On service disruptions and staff and physician shortages in Milk River, Pincher Creek and the zone.</li> <li>On the 2023-24 AHS Influenza Immunization Campaign.</li> <li>On the AHS provincial consolidation of AHS mental health and addiction programs. Effective October 23, the accountability for Addiction and Mental Health (AMH) service delivery will transition from South Zone leadership to the new Provincial AMH portfolio.</li> <li>Connect Care implementation in South Zone - all sites are scheduled to go live in Launch 7 - November 2023.</li> <li>Dr. Aaron Low, South Zone Medical Director, provided a written report that was included in the meeting package.</li> <li>An update was provided on physician recruitment in the South Zone, West:</li> <li>There are several positions being recruited for and 60 active postings in the areas of: addiction and mental health, anesthesia, diagnostic imagining, family, emergency and rural medicine, obstetrics and gynecology, pediatrics, senior's health, and surgery.</li> <li>Active recruitment is ongoing for sites in Milk River and Pincher Creek.</li> </ul>
Community Partners	Lynsey Robinson, RhPAP Consultant - Rural Health Professions Action Plan (RhPAP), provided a written report:  • RhPAP has virtual learning opportunities and events available for rural community members and healthcare providers.

	<ul> <li>There are nine family doctors in Raymond. Some of the concerns effecting other rural areas in south zone are not present in Raymond.</li> <li>Good news story from Council member sharing that her grandson who is too young to get a job, has begun volunteering for AHS and takes his service dog Winnie to visit local seniors.</li> <li>The engagement event in Picture Butte went well, praise for Dr. Aaron Low who answered many difficult questions from attendees.</li> <li>New Council member happy to be participating with the Advisory Council.</li> <li>Concerns about physician shortages in Pincher Creek; AHS South Zone leadership are welcome back to the community to share updates and good news around recruitment.</li> <li>Milk River pleased to have Dr. Meyer back in town. They've found a house, the clinic is running well and there are lots of compliments all around. As well, Hutterite women would really like to have a female doctor in town for their needs.</li> <li>Really need to have rural communities train their own for healthcare careers and encourage them to live, work, and play and enjoy the areas they are from.</li> </ul>
Voices of the	Community members expressed the following concerns:
Community	<ul> <li>Not having access/adequate healthcare services or providers in rural areas, including Milk River and surrounding rural areas, that would allow seniors to comfortably age in place.</li> <li>Concerns over walk-in clinics not being available in some rural areas. As well, concerns about service hours of the walk-in Clinic in Coaldale during the week and on the weekend. Happy to hear that walk-in services are coming to Picture Butte.</li> </ul>
	Concerns over food quality at the Pincher Creek Health Centre.
