About community engagement

Alberta Health Services is committed to meaningful and authentic community engagement. Engaging with Albertans means patients, families and members of the public contribute to healthcare solutions and the betterment of our system. They can benefit by having their needs reflected in planning and decision making. Engagement aligns with the Alberta Health Services culture of caring and listening, which results in more patient-centred care, local decision making and more open and trusting relationships.

Role of Advisory Councils

Alberta Health Services values advisory council members as volunteers, leaders and partners in healthcare planning. They help build a stronger relationship between the people in their communities and those who work in the health system.

Members of Health Advisory Councils, Provincial Advisory Councils, and Wisdom Council are Albertans who care about health of their communities, and are connected to the public in many different ways. They provide a grassroots perspective and an understanding of their communities' health needs, and they're interested in listening to the people. They also:



- share their communities' priorities with Alberta Health Services
- give advice and help to inform the decision-making process
- host public advisory council meetings, in addition to promoting and participating in activities that enhance Albertans' health
- engage with and share information with the community, and follow up on commitments
- give feedback on public education materials, policies, or discussion topics
- share information on health services with the community and provide feedback and input to Alberta Health Services

Councils attend the annual Advisory Councils' Fall Forum to hear a variety of presentations and network with fellow council members, Alberta Health Services staff and members of the Board of Directors.

The Health Advisory Councils and the Provincial Advisory Councils are supported by the Alberta Health Services Community Engagement department, and report through the Council of Chairs to the Community Engagement Committee of the Alberta Health Services Board of Directors. The Wisdom Council reports to the AHS President and CEO.

What we are proud of

Engaging with the public

- Council supported Calgary Zone long range planning through participating in engagement sessions, facilitating small discussion groups on with underrepresented populations, participating in the virtual community, submitting blog posts, and suggesting improvements to blog platform.
- A council member attended the Continuing Care Expo with the Apple Magazine team to raise awareness of Health Advisory Councils.

Providing feedback and advice to Alberta Health Services

- Our Chair and member participated in key informant interviews through the Action Learning Project which focused on developing an approach to introduce, enhance and spread family presence across the organization.
- Council supported and participated in the successful recruitment of ten new council members in fall 2016.
- Our Chair sat on the Calgary Zone long range planning steering committee.
- Council contributed to the development of the Alberta Health Services Health and Business Plan, including submitting 15 potential objectives, which were rolled into the final Alberta Health Services Health Plan objectives. Two objectives can be directly tied to council suggestions:
 - By 2020, we will improve engagement of staff, physicians and volunteers; and
 - By 2020, we will increase physical and psychological safety.
- Council provided feedback on naloxone distribution which helped contribute to the changes in public access requirements.
- Council provided feedback on the EMS driver requirements and supported expanding services.
- Council advocated against the move to a fully-online model for the Calgary Lab Services asking the Lab Services to consider barriers to access.

Enhancing the health of community members

- Our members serve on over ten committees and are dedicated to gaining a better understanding of health services in the zone and province, and to better sharing input from our communities across a wide range of health issues. Some of the committees we participate in include:
 - Cancer Provincial Advisory Council
 - Calgary Lab Services Customer Advisory Council
 - Calgary Zone Oversight Committee – Complex High Needs Initiatives
 - Calgary Zone Patient and Family Centered Care
 - Calgary & Area Medical Staff Society (CAMSS)
 - Continuing Care Quality Committee
 - Foothills Medical Centre Master Planning Steering Committee
 - Primary Care Council
 - Provincial Health Link Advisory Council
 - Rockyview Patient and Family Centered Care Committee
 - South Health Campus Citizen Advisory Team

Key learnings

- In order to better understand existing and emerging issues in health services, we received presentations from various experts and community and organization representatives on the following topics:
 - Community Engagement, Ethics and Medical Assistance in Dying, Fort McMurray Fires, Alberta Health Services Health and Business Plan development, Calgary Zone long range planning, Recovery Service Task Force, wait times, Primary Care Network, and Patient and Family Centred Care.

A look ahead

- We will spend the next year focusing on three key priority areas for the Calgary Zone, including patient first care, equitable access and wait times.
- Council will also continue to support and participate in Calgary Zone and province-wide engagement opportunities, such as long range planning.
- We established subcommittees of council members for each priority area to plan activities and tasks to drive progress.
